FAQ's

Props and training

What will be required for the training?

For the training you will need to bring your circus props with you, either bringing your own materials or renting/purchasing them in Mallorca. The organisation does not supply circus props or material, but we can help artists to find local renting/purchasing options.

Storage

The organisation does offer a space where you can store your props in between modules, provided you'd rather not travel with them.

Can several props be used throughout the process?

This will be reviewed on a case-by-case basis once the selection process is completed. At ICCAR we strive to accompany artists in their deep research on circus creation, and these processes can be extremely personal and differ from one person to another. This issue will be addressed in the initial interview

Support

Rigging and technical support will be available throughout the course, should artists need to rig circus props and/or materials (aerial equipment, pole, etc.).

Duos

If you work with a partner, you can absolutely apply! This info must be specified in the form so that it can be taken into account in the selection process.

Financial details

Price

The full price for the six-module 2023-2024 course is €3,000.00.

Payment methods

Once the applicant has been selected for the programme, he/she must make a 30% down payment (€900.00) within 10 days of receiving confirmation of being selected.

The remaining amount can be paid once the programme has already started, either in one payment (€2,100.00) in October 2023 or in two instalments, as follows:

- 1st payment by 1 October 2023: €1,050.00
- 2nd payment by 1 January 2024: €1,050.00

Refunds are only contemplated in the event of force majeure. Any other reason preventing participants from attending the training will not entitle to a refund.

Funding and scholarships

ICCAR does not currently have a funding or scholarship programme for its training. The ICCAR team is available to provide participants with the required documents they might need to apply for funding in their places of origin or for other support programmes they may have access to.

Travelling to Mallorca

VISAS

Participants in the programme must arrange their own visas and/or permits. If needed, the ICCAR team is available to provide participants with the required documents to process said visas.

Accommodation and meals

Participants are required to arrange their accommodation and meals during their stays in Mallorca.

The ICCAR team is aware of the difficulty of finding accommodation in a location participants are probably not familiar with; this is especially the case for this programme, which will be taking place in several areas. Therefore, the ICCAR team is committed to help with this issue.

ICCAR is working closely with the towns/cities hosting the programme so that links can be created which are beneficial for all the involved parties. Among others, ICCAR will provide participants with a list of accommodation options in each area with the following features:

- inexpensive or cheaper than regular accommodation
- kitchen available
- capable of accommodating several artists (houses, apartments, etc.)
- close to the course's venue or well connected to public transport to make commuting easy

Travelling

Participants must cover their travel costs to and from Mallorca. Extensive information will be provided on public transport on the island, as well as other means of transportation to make commuting as easy as possible.

Guests and pets

Pets are not allowed in the training facilities.

The organisation will not take care of any issues regarding participants' guests
